

HomeAgain® Heroes Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. OVERVIEW:** The HomeAgain Heroes Sweepstakes (the “Sweepstakes”) consists of six (6) separate weekly drawings and one (1) grand prize drawing. Entry into each weekly drawing is separate. Entry into one weekly drawing is not entry into any other weekly drawing.
- 2.
